ORDER

As per Note 2 below Rule 164(a) of KTC Vol I, the Gazetted officers are permitted to draw pay and allowances based on LPC without insisting of pay slip from Accountant General for a period of three months or till receipt of pay slip, whichever is earlier and as per the GO read first paper above, Government issued permission to draw the pay and allowances of gazetted officers during leave without slip from Accountant General, if the leave period is less than 21 days in a single stretch.

2] Now vide letter read second paper above, Principal Accountant General(A&E) has requested to extend the above period of three months exemption to six months so that gazetted officers pay and allowances can be drawn and disbursed by the DDOs based on LPC, without waiting for the AG's pay slip consequent on promotion, transfer, leave etc of Gazetted Officers considering the issues in connection with the COVID - 19 Pandemic situation.

3] Government have examined the matter in detail and are pleased to be order that the time limit of three months exemption, for permission to draw pay and allowances based on LPC without insisting of pay slips from Accountant General, is extended to six months and the facility will be available till 31.03.2021 only, as an adhoc arrangement, considering the present COVID-19 pandemic situation and is applicable only for the following cases;

- (i) Who are promoted to a Gazetted post from a Non Gazetted post
- (ii) Gazetted officers promoted to another post

(iii) Gazetted officers transferred to a different station

(iv) Gazetted officers who return from leave on expiry of leave already sanctioned.

4] Both SPARK and GEMS applications would be modified suitably to accommodate these changes, immediately, so that DDOs can draw and disburse the claims accordingly.
