General Provident Fund (Kerala) Rules 2011- Rectification of GPF Forms in SPARK and Amendment to GPF Rule related to the interval between two consecutive Temporary Advances — Orders issued.

## **ORDER**

As per GO read 2<sup>nd</sup> and 3<sup>rd</sup> paper above, Government have implemented the revised and simple online GPF forms to make them conducive to online submission and processing in SPARK. Due to some technical problems, headline for GPF TA processing form (III) and GPF NRA processing and TA to NRA Conversion Form (II) had been implemented in SPARK generated forms as Form II and Form III respectively and the same are in use since its inception in SPARK.

In the circumstances, Government have examined the matter in detail and are pleased to accord sanction to introduce the above mentioned changes in GPF (K) Rules and to continue the existing forms with Form numbers in SPARK as GPF TA processing form as Form II and GPF NRA processing and TA to NRA Conversion Form as Form III, respectively, with immediate effect.

As per GO read as 1<sup>st</sup> paper above, GPF Rule 17 (1) (a) states that - "The sanctioning authority shall not grant the advance from the Fund:

(a) unless a period of six months has elapsed after the drawal of a previous advance and a certificate to the effect that six months has elapsed is not included in the next sanctioning order", which is giving undue advantages to certain subscribers.

Government have examined this matter also in detail and are pleased to revise the existing GPF Rule 17 (1) (a) as " The sanctioning authority shall not grant the advance from the Fund:

a) unless number of recoveries not be less than six has elapsed after the drawal of a previous advance and a certificate to the effect that six recoveries has elapsed is not included in the next sanctioning order."

Necessary amendments to the General Provident Fund(Kerala)Rules, 2011 will be issued subsequently.
