ORDER

Government have issued certain guidelines for the speedy settlement of medical reimbursement claims vide the Circular and Government orders read above. Government are now pleased to order that Medical Reimbursement Claims in connection with the treatment of the diseases appended to this order, availed from empanelled Private Hospitals, without reference from an Authorised Medical Attendant, can also be settled by the Administrative Departments themselves as per KGSMA Rules, 1960, in consultation with Finance Department, as per the ceiling limit fixed in this regard. Admissible amount in full, calculated by Director of Health Services/District Medical officers concerned at Government rate, shall be reimbursed in the cases of Medical Reimbursement claims which do not need ex post facto sanction from Health & Family Welfare (G) Department.
