ORDER

Government are pleased to issue following instructions regarding sanctioning of expenses incurred for the treatment of specialized procedure of Assisted Reproduction Techniques, for information and observance.

- (i) Reimbursement of the expenses incurred for the treatment of primary infertility shall be sanctioned as earlier.
- (ii) Reimbursement of the expenses incurred for the treatment of specialized procedure of Assisted Reproduction Techniques, (ART) like Invitro Fertilisation and Embryo Transfer etc. shall be sanctioned to the deserving Government servants to the tune of actual amount spent with a limit of ₹ 1,50,000 per attempt to a maximum of ₹ 3 lakhs for three attempts during the entire service.
 - (iii) Only the couple who have no children are entitled to avail the benefit.
 - (iv) Expenses of Delivery treatment should not be reimbursed.
- (v) The DHS will verify and admit the claim preferred by Government Servants regarding IVF, etc.

- (vi) Separate register should be maintained by each Department regarding this and entries should properly be made. Entries regarding this should also be made in the Service Book of the incumbents.
 - (vii) This order shall not be applicable to those claims which were settled.
