*Sub:—* T. A. ceiling on claims for attending Training—Clarification—Issued.

*Ref:—*(1) G. O. (P) No. 296/2007/Fin. dated 10-7-20007.

(2) Lr. No. H3/11033/2011 dated 26-2-2011 from the District Collector, Malappuram.

Government employees who undergo trainings are eligible to get T. A. and D. A. as per Rule 59, Part II KSRs. If free boarding and/or lodging is provided at training centres, the D. A. will be limited as specified in Rule 39, Part II KSRs.

Now, vide the letter cited, the District Collector, Malappuram has requested Government to clarify whether the T. A. ceiling imposed as per the Government Order cited is applicable to the T. A. claims of Government employees who are deputed to attend the compulsory trainings.

In the circumstances, Government wish to clarify that the T. A. ceiling imposed as per the Government Order cited will not be applicable in the case of T. A. claims of Government employees who attend the trainings inside the State.
