## ORDER

As per GO read second above, the time limit of three months exemption for permission to draw pay and allowances of Gazetted officers, based on LPC without insisting of pay slip from Accountant General was extended to six months considering the Covid pandemic situation and the facility was available till 31.03.2021. Now as per the letter read third paper above, the Accountant General (AG) has requested to extend this relaxation for three more months.

Government have examined the matter in detail and are pleased to order that the relaxation of six months for permission to draw pay and allowances, including leave salary of Gazetted Officers based on LPC without insisting of pay slip from AG will be permitted till 30-9-2021, to handle the lock down related delay in issuing AG slips consequent on covid -19 pandemic situation and by strictly adhering to the conditions mentioned in the GO read as second above.

Also all Head of Departments and DDOs are directed to furnish all required documents (scanned copies) such as promotion/posting/transfer/leave sanction orders, LPCs, RTCs etc (except SB) of Gazetted officers to Accountant General via e-mail immediately to avoid delay in getting the hard copies of the same by post and to ensure that requests are processed and slips issued without further delay by Accountant General Office.

## THE NO. DL-3/3Z/ZUZU-TIN

Both SPARK and GEMS application would be suitably modified to accommodate these changes immediately, so that DDOs can draw and disburse the claims of such gazetted officers, accordingly.
